POLICY NO. 316

Policy Statement: It is the policy of Council to recognize the

necessity of an orderly inspection of the

Lagoon Berm.

Policy Background: The Village has a zoned earth type berm

lagoon. It is constructed at the base of the hill with the east side sloped facing the river. It is lined with plastic and is dyked in the centre with a control gate making it

Policy Goal: It is the goal of this policy to provide the

community with a safe and economical

discharge of sewer effluent.

Policy Objectives: It is the objective of this policy to provide for the inspection of the berm for any disfiguration of the crest or the slope of the berm, this is done by residual inspection walking the berm. (Spring and Fall)
