- Midway Community Association Midway Community Centre Upgrades 1) Letter received from Midway Community Association regarding the changes to the community centre upgrades. They would like to offer the following observations in summary:
  - The space allocated for the bar in the draft design is too small to be fully functional. The bar space needs to be larger in the new design, with a larger fridge/cooler-not smaller
  - The bar should have access to the kitchen. A pass through is possible but a door would ٠ be preferable.
  - The kitchen layout is very long and narrow. We understand Council has discussed this and encourage you to instruct the architect to enlarge the bar and shorten the length of the kitchen.
  - Upstairs storage space is vital. We encourage council not to minimize the storage area on the main floor as it needs to be large enough to hold chairs and tables at a minimum and ideally other equipment as well.

## Planning

Daniel Steiner, Grant Specialist – Midway Community Centre – Project Budget a) Update and SPF (Strategic Priority Fund) – CAO gave an update and overview of the Budget Scenario's provided by Daniel Steiner, however, new information with regards to an update to the Class C Estimate will affect the numbers in the budget. Information on project eligibility to apply for Strategic Priority Fund and Daniel Steiner's recommendation to apply for SPF funding first, remove the Gas Tax Fund \$90,000 previously committed to this project as that would only serve to reduce any potential approval from SPF (both federal funding), then apply for the Legacy Fund if the SPF.

If the SPF funding is not approved but the Legacy Fund is, the community centre project can still completed in 2018, albeit with a much greater financial burden to the community. At this point the funding amount to SPF has not been determined, formal resolution to apply for SPF funding deferred until funding amount determined. Strategic Priority Fund application deadline is June 1, 2017 and Legacy Fund is ongoing.

b) GMF 15174 Scope Change – FCM/GMF request an updated Class C cost estimate before we respond to their latest information request. Hopefully the final design elements will be ironed out and conveyed to Chris Fairbanks so he can finalize the design and update the cost estimates. SES is preparing an opinion on why the Level 1 Audit is sufficient for the purposes of this upgrade project. Councillor Schierbeck advised that if a Level 2 audit is required the costs would be in the \$3,000.00 range.
