## Village Office Easter Holiday Hours

Closed Good Friday & Easter Monday **Dog Tags** - 2018 dog tags are now available at the Village Office. \$15 for spayed or neutered, or \$30 for un-spayed or un-neutered. Cash, cheque or debit.

Dog owners are reminded to ensure dogs do not bark constantly during the day and night as it is a disturbance to the public and neighbours.

**Fire Permits** - Residents are reminded that burning permits are required for all burning within the Village and can be purchased for \$1 at the Village Office. This includes campfire, and open burn piles not exceeding one metre in height and one metre in width. No person shall ignite or cause to be ignited any household waste, refuse, rubbish, garbage, plastic, or styrofoam, industrial or commercial waste.

\*\*\*Please note that there are <u>Open Burn</u> restrictions: there will be no open burning allowed during the peak hours of 11:00 am and 6:00 pm. <u>This restriction applies</u> to all new and previously issued burn permits.\*\*\*

Any person who contravenes or violates any provision of this Bylaw could be liable to a minimum fine of \$500.00 and should the Midway Volunteer Fire Department/Emergency Responder be required, the Permittee shall be liable for the total cost of the fire call per Bylaw #451, Part 10, Sec. 51 (2) (3).

# **Council Meeting News Cont'd**

### Kettle River Museum - Proposed Bunkhouse Hostel

Members from the Kettle River Museum met with Council to discuss turning the Bunkhouse into a hostel for visitors to Midway. After some clarification as to what changes are being planned, Council approved to fund the proposed hostel renovation up to \$20,000.00.

### **New Fire Trucks**

At the March 5, 2018 regular meeting, the majority Council approved the purchase of the following fire apparatus for use and allocation in both Midway and out in the Kettle Valley Fire Protection Service Area in Rock Creek:

- 1. 2007 Kenworth T800 (cab & chassis) from Inland Kenworth
- 2. A new 4000-gallon poly tank and fabrication of a steel skid from Barr Plastics (The intention is to have the 4000-gallon poly tank installed on the 2007 Kenworth T800 chassis for use as a 'Tender' which is a specialized vehicle capable of bringing water to fire trucks in the field that are engaged on the fire line)
- 3. 2003 Pierce Dash Pumper truck from EastCan Fire Inc.
- 4. 2004 American LaFrance Pumper truck from EastCan Fire Inc.

At their regular meeting of March 19, 2018, the majority Council approved a \$10,000 deposit to secure the 2003 Pierce Dash and a \$10,000 deposit to secure the 2004 American LaFrance Pumper trucks.

### **Employer Health Tax**

In support of municipalities, the Council will write a letter to the Minister of Finance requesting that they consider an alternative to the Employer Health Tax. The direct impact will result in significant cost increase to municipalities who have few options to cover cost increases and will ultimately result in increases to property taxes or reductions to municipal services.

### **Road Rescue**

Council will submit their comments addressing the need for a concerted approach to the oversight, administration, and provision of road rescue service being provided by local government fire departments and the downloading of those costs onto the taxpayers for a service that is majorly provided along provincial highways. While EMBC does provide some operational cost recovery to road rescue service providers for services to out-of-jurisdiction areas, this is not the case for in-jurisdiction areas, and those costs to fund the service are through local taxation.
