

## VILLAGE OF MIDWAY

### BYLAW NO. 507

#### A Bylaw to Provide for Council Member Remuneration and Expenses

The Council of the Village of Midway in open meeting assembled enacts as follows:

#### **REMUNERATION TO COUNCIL MEMBERS**

1. Commencing January 1, 2019, the annual remuneration for the Mayor and Council members for the discharge of their duties of office shall be:
  - (a) Mayor - **NINE THOUSAND TWO HUNDRED DOLLARS (\$9,200.00) plus the Cost of Living Allowance.**
  - (b) Councillor – **SEVEN THOUSAND SIX HUNDRED DOLLARS (\$7,600.00) plus the Cost of Living Allowance.**

And every year following the 2019 year the annual remuneration set out in section 1(a) and (b) of this bylaw shall be increased by the Cost of Living Allowance.

#### **EXPENSES INCURRED**

2. Registration fees and travel expenses of spouses are deemed as expenses incurred by the Councillor while attending a meeting, course or convention. As soon as possible after delivery by a Council member to the Treasurer of written evidence of expenditures made or expenses incurred when the council member is:
  - (a) representing the Municipality beyond its boundaries;
  - (b) engaging in municipal business beyond the Municipality's boundaries; or
  - (c) attending a course or convention,

The Treasurer shall pay to the Council member the amount of the expenditures made or expenses incurred.

#### **QUALIFYING EXPENSES AND EXPENDITURES**

3. (a) The types of expenses and expenditures that may qualify for payment under section 3 are:
  - (i) hotels;
  - (ii) transportation other than by way of the Council member's own motor vehicle;
  - (iii) transportation by way of the Council member's own motor vehicle;
  - (iv) telephone or facsimile transmission;
  - (v) photocopying;
  - (vi) meals;
  - (vii) gratuities

#### **LEVELS OF PAYMENT**

4. (a) The level at which the Treasurer shall reimburse a Council member for transportation by way of the council member's own motor vehicle is \$0.54 per kilometre.

**REPEAL**

5. The Village of Midway "Remuneration and Expenses Bylaw No. 477, 2016 and all amendments thereto is hereby repealed and replaced.

**CITATION**

6. This bylaw may be cited as "Remuneration and Expenses Bylaw No. 507, 2018.
