#### **ICBC & Motor Vehicles**

The Village of Midway Office offers all of your ICBC Autoplan and Drivers Services needs. **Tree Recycling Facility** - Has reopened for the 2022 season. We will be returning to the \$10 annual fee. You can pay the fee at the Village Office when you pick up a key. Keys will need to be returned to the Office once you are done with it. The only materials allowed at this site are grass clippings, noxious weeds or branches or bushes that have been pruned. Since the facility has reopened, someone dumped industrial

waste. Not only will the nails damage a chipper but they are a risk to everyone that goes in there of getting a flat tire. Residents, please help us keep this facility open and only use it for its intended use. Residents are encouraged to be vigilant if they see any suspicious behaviour and to call R.A.P.P (1-877-952-7277) to report any illegal dumping.

If you do not have access to the online version, please contact the Village Office for a hard copy. <u>Midway Community Centre</u> - Renovations will begin in late Spring/early Summer. In preparation for that, we will be unable to accommodate any bookings at "the Hall" starting **July 1, 2022**. \**new date*\*

Midway Community Garden - The Midway Community Garden would like to remind residents that there is a compost pile at the garden for compostable materials only. NOT for branches, etc. They would also like to thank residents for using the bottle recycling bin located on the corner of Cleghorn St and Seventh Ave, near the Arena and ball field. It is NOT FOR: garbage, plastic or paper recycling or anything other than drink containers that are eligible for a deposit refund.

**Dog Tags** - 2022 dog tags are now available at the Village Office. \$15 for spayed or neutered, or \$30 for un-spayed or un-neutered. Cash, cheque and debit are accepted.

**2022 Business Licences** - The \$50 annual fee is due in January for businesses operating in the Village of Midway. Fees can be paid at the Village Office by cash, cheque or debit.

**<u>Fire Permits</u>** - Residents are reminded that burning permits are required for <u>campfires</u> within the Village of Midway and can be purchased for \$1 at the Village Office.

<u>Camp fires must be supervised until it is completely</u> <u>extinguished!</u> This means no walking away to let the fire smoulder until it's out.

No person shall ignite or cause to be ignited any household waste, refuse, rubbish, garbage, plastic, or styrofoam, industrial or commercial waste. The office door is still closed to the public but window service is available.

# <u>\*\*\*Please note that Open Burns AND Category 3 fires</u> <u>are prohibited.\*\*\*</u>

Any person who contravenes or violates any provision of this Bylaw could be liable to a minimum fine of \$500.00 and should the Midway Volunteer Fire Department/Emergency Responder be required, the Permittee shall be liable for the total cost of the fire call per Bylaw #451, Part 10, Sec. 51 (2) (3).
