Karen provided an informational presentation regarding the Municipal & Regional District Tax (MRDT). MRDT is a 2% on the purchase of accommodation imposed in the Boundary on the behalf of the RDKB. The tax is intended to help grow BC revenues, visitation, jobs and amplify BC's tourism marketing efforts in an increasingly competitive marketplace. Revenue from the MRDT has been spent on tourism liaison staff, advertising, trade shows, guidebooks, and signage.

Karen hopes that Council will pass a motion to endorse the renewal of the MRDT.

Mayor McMynn asked how would a smaller operation (ie Bed & Breakfast) would be enforced to pay the MRDT? It would be captured and expected by the BC Government the same way the PST is collected.

Vickie Konkin asked where did the guideline stating only businesses with 4+ rooms would pay the MRDT go? Yes, it has changed to a one room requirement. Karen will send Penny the updated guidelines to share with Council and Vickie.

Councillor Willsey asked Vickie Konkin why that is important to her? She stated she is aware of some businesses in the area who declared they had fewer rooms available in order to avoid paying the MRDT. In the past 4.5 years the Mile 0 Motel has collected approximately \$15,000 in MRDT and she feels there has been little to show for it with regards to bringing customers into Midway.

Vickie asked Karen long stays (28+ days) customers who are eligible to request MRDT back, where does the money come from? Karen said it comes out of the pool of money that the Province collects from all contributors.

It was noted that Council must decide on whether to endorse the renewal of the MRDT by November 28, 2022.
