# Mayor and Council Reports

Councillor Dunsdon

- Attended a TOTA meeting about the MRDT tax and tried to impress upon them the need to provide some funding to ٠ iurisdictions as this would be good for optics.
- Think about being involved in the Wild Safe program. Program costs is \$4000 but our funding commitment would be \$500. This program would include public meetings, utilize signage, Village newsletters and provide information to schools dealing with wildlife, bear aware and safe garbage storage.
- Noxious weed control costs have been approximately \$1000 per year. Costs may go up this year. Must ensure to include in this year's budget. Spray for knapweed, Hoary alyssum, and other noxious weeds along roadways and trails.
- Community Futures on help with laid off workers. As discussed earlier, will have Jennifer come back to answer more • auestions.
- There had been a 4% increase in building since last year. Permits totalling \$22,964.00
- RDKB only has one year left on the 911 emergency call program. No ideas on what happens after the contract . ends
- RDKB Area E has paid out \$27,000 for the arena and Library. \$4000 is still a go for 2023. There is a call on schedule for more information about this coming up shortly.
- RDKB Area E helping to pay the Fire Chief there is another meeting with James Chandler to find more money in the budget. The Village is looking for more money from RDKB for Fire Chief Daloise's salary. Possibly a 5% increase in the budget.
- Privacy policy (Bill 22) for the RDKB is being downloaded to municipalities for privacy accountability and FIPPA . requirements.
- Warming and cooling centers, do we need a policy? The Fire Department has had cooling centers established before with no one utilizing them. See what RDKB will do in the future about a policy.
- Visitor center designation for the museum could be \$10,000 for a partial year and \$15,000 for a full year. The Riverside Center in Rock Creek has been awarded the full amount. Does Wendy Higashi know about this designation funding? Destination BC.
- Splash park, capital projects are pretty much straightforward, the kicker is always the operational side of things. What thought has been given to this issue.
  - Note: Councillor Dunsdon wants to go on record as being opposed to the Splash Park project. Feels there are more urgent options that could be dealt with.
- We need to publish our priority list if communication and transparency are priorities. We need to update as . necessary and publish them as we can. See where we want to go. The Strategic Plan. Public, Council and possibly an outside party assist with this plan.
- We need Council representation on the Parkview Manor as they are contemplating an addition Councillor Pownall . has been given that task.
- Summerland and Oliver (6-month trial basis) have gone to or are going to a three-week meeting schedule. Merritt is presently once a month. There has been no feedback about Merritt. Any thoughts? Are we interested?
- Are we part of a Loan Forgiveness program for Doctors? Is Midway eligible? 20% of loan is forgiven over a 5-year term. It was noted that Oliver is NOT eligible.
- AKGBL attendees. Already organized for Councillor Willsey and Metcalf to attend.
- Urban systems, have we heard anything back about the property west of the Arena? CAO may have some information.

- RDKB meeting a lot of increased money needs and therefore increases budgets.
- Online meeting for Women Leading Change in Business How to break the Bias from University of Victoria.
- From the University of Fraser Valley attended some online courses about civic government & forming relationships ٠ with Indigenous groups.
- Columbia River Treaty meeting this does not impact us and is not interested in going again. Councillor Dunsdon ٠ pointed out that there may be future implications as the Kettle River is a tributary of the Columbia River. There have been a few Literacy programs that we have benefited from.
- Kootenay Boundary Hospital board meeting the Boundary District Hospital is still open for 24-hour emergency care. They have intensified their recruiting incentive for staff, physician, nurses, technicians, etc. Expecting 4-6 beds to be opened shortly. Noted that Castlegar spends \$50,000 towards retaining their doctors. Hospital occupancy has been reduced from 141% down to 88%.

- February 23rd at 11:00am a meeting with the Ministry of Transportation to discuss Road Access permits, 70km speed limits along the highway corridor. RCMP will participate in discussion,
- Community Forest meeting on February 28th, 2023 at 6:30pm at Greenwood. The Community Forest program is still going. Changes are happening. Vaagen will still sell wood. Community Forest program will work with the same people, same program, just a different Boss. Dividends will have some adjustments made and those will be discussed at the upcoming meeting.
