Vaagen Fibre Canada - Mill Closure -summary of telephone conversation

- CAO and Mayor McMynn spoke with Darry Reekie, Mill Manager, regarding the mill closure.
- Challenges with accessing wood fibre at market prices.
- Vaagen Fibre Canada is a non-tenured mill and has been operating in Midway without forest tenure for the past 10
  years they do not have forest licences to manage Crown forests, which means they must purchase all our logs on the
  open market including the procurement of logs from local private landowners and woodlot owners.
- The future of the operation is uncertain.

Staff directed to write to Federal NDP Leader, Richard Canning, MLA Roly Russell, Minister of Finance, Katrine Conroy, Premier of BC, Dave Eby regarding the mill closure and how the government can help small mills without any forest tenure stay viable into the future. Councillor Metcalf will contact Dan McMaster, RFP, to give important information for letter.

Bzam Management Inc - Will start operations again 2024 and be modernizing the facility.

Government is giving each municipality \$1 billion in grant funding. These one-time funding grants are going out to every local government in B.C. to help them address infrastructure and amenities needs, such as affordable housing, road improvements, emergency services, or childcare facilities. Local government will determine what infrastructure and community amenities projects the funds will support in their community.
