## Introduction of Late Items - None

## Adoption of Agenda

Moved/Seconded that the March 6, 2023, Regular Meeting agenda be adopted as circulated.

### **Delegation**

- a) Monica Nederend and Bruce Blackwell of B.A. Blackwell and Associates Community Wildfire Protection Plan Overview. The Power Point presentation included plans update to our 10+ year old Community Wildfire Protection Plan with a new Community Wildfire Resiliency Fire Plan.
- Over the last 10 months they went over background and field work to develop the plan which includes identifying
  wildlife threat thru spatial analysis and interpreting that data to come up with 29 recommendations to increase wildfire
  resiliency.
- The area of focus is the Eligible Wildland Interface (EWI) as outlined in the Provincial CWRFP (Community Wildfire Resiliency Fire Plan) guidelines. Note: Plan does NOT include private land, only area within the municipality.
- The recommendations are based on the Fire Smart disciplines: Education, Legislation and Planning, Development Considerations, Cross Training, Interagency Co-operation, Emergency Planning and Vegetation Management.

West Boundary Community Forests did some mitigation last year and now the remainder of the area is under a prescription for fuel management. When Blackwell reviewed the area, it was noted that logging had occurred in the past and merchantable timber was light, so understory treatments and downing of standing dead timber was the main focus.

### Monica leaves at 19:30

The CWRP assessment for the municipality was grant funded. Midway's CWPP plan was over 10 years old and any future funding for Fire Smart or Fire Resiliency work needs to have a current Community Wildfire Resiliency Plan. The plan is now updated and just a guideline to make sure we are keeping up with necessary assessments and treatments for mitigation.

Midway Evacuation plan should be assessed and if grant money is available to update this plan. Early warning information is available to the residents through Midway's Voyent Alert system whereas, the Regional District will not put out an early warning message regarding evacuations.

- b) Sandy Elzinga, Manager of Community Economic Development, Community Futures Boundary Proposed Regional Economic Diversification Plan
- Update on progress with the REDIP-FIT (Rural Economic Diversification and Infrastructure Forest Impact transition) Fund.
- It was decided that the Village of Midway would be a better applicant than the Regional District and the RDKB would be providing a letter of support to the Village for that application.
- The RDKB voted to make it a Regional Plan but with special emphasis on Midway due to the recent loss of jobs from Vaagen Fiber Canada.
- The planning phase (Forest Impact Transition FIT) is for \$500,000 and is 100% covered with 15% allotted to project
  management. The Letter of Intent application and projects identified is required for this phase. Community Futures
  Boundary would manage the project and any cost would come out of the 15%. There would be minimal resources
  and costs of the Village of Midway. Once the application has been made, a stakeholder engagement process would
  occur to identify their 3 top priority projects. Business cases would be developed for those top 3 priorities.
- From those priorities, additional funding could be applied for. These projects could be identified any place within the Boundary area but will be unknown until the stakeholders identify their priorities.
- Job loss from Vaagen was spread equally throughout the West Boundary 33% from Midway, 32% from Greenwood, 12% from Rock Creek, 11% from Grand Forks and the remainder from Westbridge, Oliver, Osoyoos and Kelowna.
- The planning phase is expected to last 10 months. It will take time to gather information from the stakeholders, digest the data and implement the pieces in order to move forward.

- If the process is started April 1, 2023, and the Province approves the funding to Midway, for this fiscal year, the process may be able to be completed by the end of January of 2024. There is likely to be further funding out there for implementation of projects.
- To maximize the budget in order to move forward with the Expression of Interest, RFP, contracts for consultants in place, get the committee's established with good communication between the Village of Midway, Boundary Services Committee and all other stakeholders identified, within that 10-month time frame. Community Futures role can be the first point of contact or adjusted to reflect what the Council needs.
- The implementation phase is the second portion of this process and the Village of Midway does not necessarily need to be as involved.

Councillor Willsey was concerned what the term *"Regional"* defined for area and that as more things were going to HUBS, then most of funding might be allocated to Grand Forks. The Boundary region encompasses the area from Christina Lake to Bridesville and up to Beaverdell/Carmi. Big White is also part of the Boundary region, but Sandy was not clear if it was included. The Boundary Service Committee tends to portion out funding throughout the Boundary, recognizing the differences within this region and portioning out Economic Development by these differences. The implementation phase can be part of the top 3 priorities but not necessarily. Pockets of different funding can be accessed for projects that have a solid business case. Councillor Willsey and Metcalf still concerned about the Regional based application funding projects that are not within the West Boundary area. The need for non-forestry related businesses; perhaps agricultural development projects would be preferrable. Councillor Dunsdon noted that this money is just to set up this project, what happens afterwards is up to the Village what we want to do with it. The Village will be a stakeholder. Community Futures have drafted the application with some more information needed before the application can be submitted.

No motion was made. Motion to be brought to next council meeting.

Council thanks Sandy Elzinga for her presentation.

<u>Question Period</u> – Martin Fromme asks Sandy Elzinga: after the application has been made and the funding is available who does the research? A hired consultant? Would the Community have representation? If the municipality was represented, then we could ensure our needs/projects be prioritized. Sandy noted that this is not a research project but a Stakeholders engagement process of which the Village of Midway is definitely a stakeholder. Stakeholders could include the Osoyoos Indian Band, Community Forests, Village of Midway and perhaps some of the contractors within the community. Agriculture representation may also be included.

Staff is recommending the addition of a partition wall with new doorway, creating a hallway to the files and safe for use by other employees.
