Delegation

- a) Patricia Henley President of the Trails to the Boundary Society made a presentation to the Council, of their 2022 Year-In-Review. Showcasing their growth and activities of 2022, projected updates on RDKB contracts and their goals moving forward. They report to RDKB and their obligation is to make sure their goals are met and reported.
- They were established in 2015 with the primary purpose of Community and Economic development across all communities in the West Boundary and have non-profit directors representing Bridesville, Rock Creek, Midway, Beaverdell, Westbridge, Greenwood and Big White.
- Lumin McCutcheon is the Economic Development Manager, Ciel Sander is the Trail Coordinator, Anu Baliyan is the Administrator, Vicky Gee is the Community coordinator and Marilyn Hanson is the Midway volunteer representative.
- They have agreements with the RDKB for stewardship of the Trans Canada Trail, for the Kettle Valley Schoolhouse Heritage project, an Economic Development position and the lease/operation of the Riverside Centre.
- They have Partnership agreements with the Province for a155km section of the Trans Canada Trail, and the Kettle River Horse Trails.
- Some projects included are the Rock Creek Visitor's Centre, the West Boundary Connect website, Kettle River Echo Newsletter, Bird Watching and Awareness day, Seniors Being Seen Engagement Program.
- The Society has been awarded a \$25,000 grant, last year and again this year, for the Seniors Being Seen Engagement Program. The Center offers free weekly presentations that include a healthy snack/meal afterwards for attendees/seniors who need and benefit from that option. Operating same days as the Food Share center is open
- The Society received a REDIT grant and is in the process of updating the West Boundary Connect Website.
- The Society has been awarded several grants towards preserving the Kettle Valley School house and have just received the finalized report from the engineers.
- The Riverside Centre was originally established a Co-op based as a business model but failed miserably so the RDKB purchased the Centre and it will now be managed under a community-based model with expected repayment of startup costs within 5 years. Work continues on systems and policies to ensure the Riverside Centre is successful.
- The Centre is busy with an Osoyoos Credit Union representative here 2 days a week, the ATM, EV charging stations, visitor information, public gathering space, office and boardroom rentals are just some of the services present.
- Shari Doratti is the West Boundary Connect website administrator. Website use is expending rapidly with lots of
 exposure on local information and activities.
- The Kettle River Echo publication goes out, FREE, to 1000 households within the West Boundary area. The Echo pays for itself thru subscriptions and advertising.
- Their mandate is to support non-profit, local businesses. Although we are in Rock Creek, the Centre is willing to collaborate with anyone is the West Boundary, including Midway. Sponsoring well attended computer courses.
- In Beaverdell the Society is interested in having work completed on the trails there and are working to access available money from Tech.

Administrator's Report - Written

- 1. Covid Restart Funds remaining at Dec 31, 2022 \$369,606. CAO to bring a report back to Council for discussion on eligibility and direction from Council on use of the funds in the 2023 Budget. It was noted that no Capital projects are allowed for expenditures with this fund, they must be related to covid. Now that we are past Covid restrictions, the guidelines still have to be followed. The CAO is hoping to have time to being back a report on May 1st, 2023.
- 2. The 2022 year-end Trial Balance has been given to the auditors. The remaining Audit work and completion of the financial statements is being completed remotely. Auditors were hoping to present the Audited Financial Statements at the May 1st Regular meeting, but they have advised staff that they will need more time to complete them. Would Council be agreeable to having a Special meeting on 11th or 12th May, so that the Financial Statements can be approved in time for Ministry deadlines? They are looking to present on Thursday May 11, 2023. The financial statements must be approved May 15th, 2023 and sent to the Ministry. A 6:00pm meeting will be scheduled for May 11, 2023.
- 3. Met with REDIP Funder Managers, Prov of BC Regional Manager, South Okanagan/Boundary Region and Community Futures regarding the Regional Economic Diversification & Infrastructure (REDIP) grant application. They requested that budget costs be scaled back for the Stakeholder engagement sessions. On the call, there was discussion around there being REDIP funding available for the priority projects that come from Plan. This funding is likely to be available for the next two years. This funding can be used for Midway specific projects. The application has been resubmitted and the cost scaled back.
- 4. Budget 2023 Budget meeting dates to be discussed at the meeting. The first two weeks of May will need several meetings allocated for the Budget. On Wednesday May 3, 2023 we will have a budget presentation. The meeting will need to be advertised for that date.
- 5. Posting has been advertised for vacant Public Works Position. The job posting was incorrectly posted in Ashcroft instead of locally. It has now been reposted locally, for free, with the deadline of Friday, April 28,2023 at 4:30pm.

Mayor and Council Reports

<u>Mayor McMynn</u> — Verbal

- Highway 3 meeting Tourism is fighting for highway improvements between Rock Creek and Christina Lake.
- Telus did not fulfill their cell service contract and so Rogers will complete it with cell service coverage.
- Received a letter from Interior Health Six doctors want to track how the controlled drug substance act is working. They want to see if there is an increase in problems on the street.
- The meeting at the Community Hall about a Health hub was discussed. It appeared they wanted to add another layer of government. Funding and direction still to be confirmed. Someone should really speak to the doctors and

practitioners, so they can add their thoughts and needs. We should wait and see what progresses. They did look at the Elementary School but said our Medical Clinic is too small for their needs.

Councillor Metcalf — Verbal

- The West Boundary Community Forest dividends are \$100,000 currently, they are holding back some funds due to the audit. There is expected to be more dividens once the audit is completed.
- The next West Boundary Community Forest Meeting is Tuesday, April 25, 2023, at 6:30pm at Greenwood City Hall
- Radon surveys Is it possible to obtain Radon kits for the community? Can we look into purchasing some in bulk? Public works has looked at the reports on some Village buildings and has added more buildings that need to be looking into for testing.
- There were a few fallen trees, above the bridge, in Boundary Creek. Reid Hedlund, Owner of Mid Boundary was able to move his machine into cut/clear the tree and a few other hazard trees without impacting the creek. The costs for this work is being were covered by the Emergency (EOC) program without any costs incurred by the Village.
- Councillor Metcalf wanted to add a comment about the April 16, 2023 sewer issue, saying that it was handled well by
 public works and the staff to get the information out to the public. Disposable wipes are still a significant issue for the
 sewer system. A septic truck was utilized from Rock Creek and another one was called in from Grand Forks. A
 posting was made on Facebook, but staff are looking at utilizing the existing Voyent Alert system to be able to reach
 more residents about local incidents/emergencies. Information on the Voyent Alert system will be added to the
 Newsletter once the further information is obtained.

Councillor Pownall — Verbal

 Met with Public works a few weeks ago with regards to the parking out front, at Parkview Manor. Public works doesn't see an issue, but he needs to know where exactly the building will sit. Street access will require adequate culvert and drainage.

- Rogers is going thru an amalgamation and part of it is creating 300 jobs in Western Canada. Perhaps a Call Center in the Midway Elementary school?
- Do we have an email policy? Yes, we do.
- There are some trees in the park across from the Arena have dead tops/spears that should be brought down. The trees need to be assessed for removal, but the company was just in town. CAO will speak with Public works Foreman about scheduling an assessment.
- The music group proposing a mid-week show, Councillor has concerns about their business operations. Did we
 advertise for summer students? The request for funding was not completed last fall for summer students so no
 advertising was done for this year. The CAO will ensure that the request for funding gets completed in the fall of 2023.
