  - Admin Computer/Server upgrades
  - Fire Protection New Fire Dept truck will leave for now. Need to discuss further.
  - Paving none allocated for this year, scheduled in 2024 Capital Plan.
  - Public Works Cemetery Improvements 2024 further discussion required on April 15, 2023 Cemetery item.
  - Recreation, Parks & Green Spaces the Spray Park is 100% funded. Playground equipment to be upgraded via grant funding next year. Riverfront Park needs a bathroom upgrade and plan needs to be put in place for a Riverfront expansion.
  - Municipal Buildings Community Hall upgrade money allocated from grants, and Village contributions, Arena dehumidifier expense relates to completion of 2022 Arena project.
  - Total General Capital estimated \$1,771,346.
  - Sewer Main lift station requires work safety platform, alarm system for other side of River recommending Gas Tax funding.
  - Sewer Capital Estimated \$96,000
  - Water New Well Rehabilitation Allocated for 2024. Amount will need to be increased.

A few questions from Jan Kohlhauser regarding the need for the Midway Public library on issues of access into library. An Accessibility Study was done pointing out issues with the library 1) Automatic opening doors are needed and 2) a ramp to access the basement. Who would do that work? Further discussion on this request will commence at the next budget meeting.
