 Moved/Seconded that the Council of the Village of Midway approves a one-time increase to the Midway Public Library grant-in aid for 2023 of \$5,000. The funds are to be taken from the COVID restart grant.

Boundary Minor Hockey. Request to open the arena early. Challenges with early opening (staffing, weather, expenses, use of building) was discussed. The number of teams operating out of BHMA is concerning, there was only one team last season. Hosting tournaments to increase use is a challenge due to lack of accommodations. The arena lost approximately \$120,000 in 2019, \$105,000 in 2020 and \$129,000 in 2022. Including the GIA received from the RDKB in 2022, the arena still lost just over \$100,000. Moved/Seconded that the Council of the Village of Midway declines the request by Boundary Minor Hockey to open the arena early, due to budget constraints. Carried 029-2023

2023 Tax Rate & Revenue Analysis

CAO provided 3 scenarios for a tax rate increase: 2.5%, 3% & 4%. After discussion it was, Moved/Seconded that the Council of the Village of Midway approves a 4% tax increase for 2023 taxation year.

Letter - Anne Kang - Growing Communities Fund Grant

How should the Village approach using the Growing Communities Fund grant? A decision does not have to be made soon but planning and discussions should begin. Well replacement, paving and sidewalks, Riverfront Park expansion (including new washrooms) were discussed. Councillor Willsey feels affordable housing and using the property west of the arena should be a priority.

CAO reminded Council that more meetings are planned for this week. The Financial Plan and Tax Rate bylaws require three readings before adoption. The auditors are already scheduled to present the Financial Statement on Thursday May 11 at 6pm. A meeting could be scheduled on Wednesday for the three readings and do the adoption after the presentation by the auditors. Or three readings after the auditors on Thursday and adoption on Friday. Council agreed that meetings on Wednesday and Thursday would work the best.
