Delegation - Kettle Valley Bike Track Group

- A group of people who are interested in building a Pump track, for any aged group, who wants to learn how to ride the mountain trails.
- A Pump track is a scaled-down version of a BMX track (Grand Forks has a full-sized BMX track)
 - Ride around without much pedalling required and learn how to utilize the ground.
 - o Kettle River Provincial campground has a track which has high use
 - Trending in a lot of communities. Can use any bike no need to have a specialized bike.
 - o Surface can be asphalt, cement or modular (specialized). Dirt can easily changeable and a good start.
 - Most injuries are minimal, with light abrasions or scratches; high speeds are not common.
 - It is NOT a racetrack, more for training of bike use.
 - By setting this up and having people learn the skills, they will then utilize our local trails.
 - Grants are available for Bike Tracks specifically Pump tracks due to trends with outdoor recreation or Tourism grants available.
 - West Boundary Community Forest is interested in this activity and has some property across the bridge. There are some concerns about location and crossing the bridge for younger kids.
 - In principle, the group would like Council to consider a spot for Pump Track location on Village property. Would prefer to be in town, perhaps by the campground. Washrooms and amenities would be close and easily assessable for children.
 - o The size of the pump track would be comparable to the size of the Village parking lot.
 - The group's vision is to build original track from dirt, then expand to pavement or cement, using grants for funding future expansions but once paved then it opens ups to skateboard and other users.
 - Liability Concerns are minimal.
 - Costs would be bare bones with dirt and machine time possibly donated? Or the purchase soil may be necessary?
 - Kettle Valley Racing Association may front money for a grant application.
 - The track would start as dirt, then use calcium chloride to harden it or start with clay for hardening surface.
 - Fundraising would be possible by the group.
 - A composite picnic table for sitting would be nice for viewers.
 - Maintenance would be minimal, if paved, but rakes and small tools along with access to some water, would be used for keeping deer/mud in order, generally at the beginning of the year.
- In principle, the group would like Council to consider a spot for Pump Track location preferably on Village property and for them to organize a committee if it the idea is amendable to Council. Council will discuss further at a future meeting, under new and unfinished business.

Andrew Simmonds had a question about the timeline on the Spray Park? Request for Proposals for construction have not yet gone out. Engineering design works need to be completed first. The grant is good until June of 2024.

- Province of BC, Ministry of Tourism, Arts, Culture and Sport Destination Development and Science World Announcement. Councillor Willsey noted that there are not items regarding our area. <u>Moved/Seconded</u> be received and filed.
- b) Midway Public Library – Accessibility Audit. Numerous items can be addressed by the Library staff. Automated doors have been put in the budget. Most of the audit is based on suggestions, not that the recommendations must be done. The most significant item is the Accessibility Plan. Unclear who paid for the Audit. A chair lift/glide was recommended for access to the basement. The Public Works foreman has some of these items already on his list to look at or deal with this year. The CAO will review the list with the Public Works foreman. Library staff can address items like potential fall items/boxes, desk at basement door, and plant that needs to be moved. At one time there was no access to the basement as there was not second exit from the building? and public access was not allowed. Has that changed? Perhaps the Fire Chief can have a look? Access in front of the building needs to be changed so it is not two entrances separated by the rock feature. All chairs are wheeled and are an issue for the elderly/public, but who fixes that? Library staff? Funding would be an issue for the Library. Library is open 4 days a week with 1-20 people per day and 80-100 per week. Councillor Willsey says use is impressive if that is what they are averaging. A plan for attaining compliance is due by August 31, 2023. CAO to respond to letter. Moved/Seconded that the Council have the CAO and the Public Works Foreman review the Accessibility Audit of the Midway Public Library to determine schedule and feasibility of recommendations and report back to Council. Carried

- Reid Hedlund went to the Ministry of Forests to express how the closure of small mills in small communities' effects everything from doctors, pharmacies, stores; everything in the community. The Truck Loggers Association wants to interview Mayor McMynn, who insisted Reid Hedlund also be included, on Thursday, May 18th, 2023, at 2pm about economic development of small communities. After P&T went down and another mill re-opened, Midway won an economic award during that time. That will be discussed at the interview, but details will be reviewed prior to interview. Reid Hedlund provided a significant amount information to the Ministry already. There is a perception of lack of services in small communities but when there are job losses and people have to move, infrastructure can not be maintained to the standards of larger-sized communities.
- There is lots of concern about the deck being built adjacent to the trailer on 5th Ave. What actions are occurring? Do commercial properties have different standards? The CAO is working on a few options and steps are being taken to address the situation.
