NOTICE OF PUBLIC HEARING NOT BEING HELD ZONING AMENDMENT BYLAW 561, 2024 FOR PROVINCIAL SMALL-SCALE MULTI-UNIT HOUSING

Pursuant to Section 481.3 (2) of the Local Government Act, the Council of the Village of Midway must adopt a zoning amendment bylaw by June 30, 2024 to allow for Provincial Small-Scale Multi-Unit Housing Legislation. This includes allowing two dwelling units per parcel in the Residential 1 and 2, Rural Residential 1, Agricultural Resource 2 and Open Space 3 Zones.

Pursuant to Section 464 (4) of the Local Government Act, a Public Hearing must not be held for the sole purpose of complying with the provisions for Small-Scale Multi-Unit Housing. Pursuant to Section 467 of the Local Government Act, notice of a Public Hearing not being held must be given prior to first reading of the bylaw.

THEREFORE the Village of Midway will consider first reading of Zoning Amendment Bylaw No. 561, 2024 on April 15, 2024 at 7 p.m or such subsequent dates and times to which the matter will be adjourned in the Council Chambers, at the Municipal Office, located at 661 Eighth Avenue.

The proposed bylaw may be inspected between the hours of 8:30 a.m. until 12:00 noon and 1:00 p.m. to 4:30 p.m., at the office of the Village of Midway, 661 Eighth Avenue, Midway, B.C., Monday through Friday, excluding holidays. You may request a digital information package to be sent to you by email by sending your request to midwaybc@shaw.ca.

Any person may make written submissions relating to the proposed bylaw up to April 12, 2024 at 4:30 pm. Your full legal name and address must be included in your written submission. Please note your comments and submission will form part of the public record.

Midway Community Centre Upgrade Project

Update – Staff and the Council of the Village of Midway are waiting in anticipation for the bidding process to close on BC Bid*. The project went out to tender in March, 2024 at a smaller scope and the tender process closes on April 16, 2024. The design scope will ensure that the building is more energy efficient, and the upgrades will greatly improve wheelchair accessibility. The Village was successful in receiving \$1,585,660.00 in grant funding for this upgrade, \$1,185,660.00 from the Investing in Canada Infrastructure Program Fund (ICIP) and \$400,000.00 from the Building Communities through Arts and Heritage (BCAH) Fund. At the March 12, 2024 Regular Council meeting, Council released the approval of a construction budget up to \$2.2million for this project. Dividends received from West Boundary Community Forest and contributions made to the Community Hall Reserve Fund will fund the remainder of this project.
