BYLAW NO. 570, 2024

A Bylaw to amend the Village of Midway’s “Cemetery Operation and Administration Bylaw No. 531, 2021”

Whereas pursuant to the *Community Charter*, the Municipal Council, may by bylaw, regulate, prohibit, and impose requirements in relation to municipal services:

(Under Bylaw Section):

- 3.1d In respect of an unused (reserved) plot or a cancellation, the purchaser has a right of a 50% refund upon written application stating the reason the plot is no longer required;
- 3.2 The Village reserves the right to refuse to sell the use of more than two grave spaces to any one individual;
- 3.3 A holder of a grave space or spaces may sell or transfer a reserved grave space to another individual by first notifying the Village, in writing, giving the full particulars of the name, address or other description of the person to whom the transfer is desired. Upon receipt of the transfer fee and upon compliance with the requirements of this Bylaw, the Village shall record the desired transfer;
- 3.5 If a grave space previously sold has not been used and (a) the lot holder with the right of interment, if living, would be at least 90 years of age, (b) a period of at least 50 years has elapsed from the date the space was sold, and (c) the operator has been unable to locate the space holder after having given notice by mailing or delivering the notice to the last known mailing address provided to the operator, the operator may apply to the registrar for permission to reclaim the grave space and to sell it to another person.

GRAVES WILL BE OPENED NO LATER THAN TWO HOURS PRIOR TO FUNERAL. GRAVES WILL BE CLOSED ON THE SAME DAY OF THE FUNERAL WITHIN A MAXIMUM OF THREE HOURS FROM THE TIME SPECIFIED ABOVE.

IT IS MANDATORY THAT THE FUNERAL DIRECTOR (OR OTHER RESPONSIBLE ADULT) STAY AT THE GRAVESITE UNTIL THE OPERATOR RETURNS TO COVER THE GRAVE
